Visiting Regulations - Separate Infantry Blockhouse MO-S5 "Na Trati"

I. General Provisions

- 1) The museum is operated by the Klub vojenské historie Bohumín, z. s. (Military History Club)
- 2) These Visiting Regulations apply to visitors of the MO-S5 construction, participants of events held there or in its vicinity, and other persons entering the premises of the bunker. You can enter the construction is at your own risk.

II. Opening Hours

- 1) The museum is open for visitors from April to September and on October 28th, on weekends and public holidays from 2 to 6 p.m. By prior arrangement, you can visit the building also outside the opening hours.
- 2) Collective tours, as well as school field trips, must be announced in advance by telephone or email.
- 3) Visiting days and hours may be adjusted according to operating conditions. Visitors can always learn about these changes on the Museum website.

III. Admission Fee

- 1) The admission fee shall be paid prior to the tour commencement. Its amount is published on the Museum website and is present on its premises.
- 2) The admission fee can only be paid in cash, in Czech crowns, Euros or Polish złoty.
- 3) Upon payment of the admission fee, the visitor receives a ticket that he/she shall carry throughout the tour. School (field-trips) groups do not obtain a ticket but a collective receipt. The receipt serves as a ticket and is valid for the particular day. The ticket is non-transferable, is valid only on the day of purchase, and only for one tour of the bunker.
- 4) By purchasing the ticket, the visitor undertakes to respect the Visiting Regulations.
- 5) Persons under 15 years of age and educators (teachers, educators, coaches, leaders of children's groups) accompanying a group of children are entitled to enter the bunker free of charge.
- 6) Groups of children (school classes, high school classes, after-school clubs, children's camps) are entitled to reduced admission fees.

IV. Guided Tours

- 1) The bunker can be solely visited only in the company of a guide giving an explanation. There is no minimum number of persons per tour. However, the maximum recommended number of persons per tour is 15 persons.
- 2) Children under 15 years of age are only allowed to enter when persons over 15 years of age accompany them. These persons are responsible for their safety and behaviour.
- 3) When school (field-trips) groups, interest groups or other organised groups are visiting the museum, educators accompanying the groups are responsible for them.
- 4) Tours start at 2:00, 3:00, 4:00, and 5:00 p.m.
- 5) The tour takes about 60 minutes.

V. Preservation of the Monument and Security of Collections

- 1) In the course of their stay in the bunker and its surrounding area, visitors are obliged to behave in accordance with the rules of civic coexistence with dignity corresponding to the historical, social and cultural significance of the object.
- 2) Visitors are required to follow the directions of the guide.
- 3) Access to the property is forbidden to persons reasonably suspected of drunkenness or drug use.
- 4) Dogs can only be admitted by agreement and on approval of the guide.
- 5) It is forbidden to damage any object, exposition or any other property in the bunker and its surrounding area, or:
 - To handle the exhibits and items on display or dispose thereof,
 - To leave the guided tour and move away from the tour guide and the group,
 - To disturb the explanation of the guide by making noise, or to complicate the tour for other visitors,
 - To eat and drink inside the bunker, enter the building with food, ice cream, drinks, etc.,
 - To throw trash away from trash bins, or
 - To otherwise disturb peace and order.
- 6) On the premises, visitors can photograph, film, and make other types of documentation only for their personal use. Visitors are forbidden to take pictures of security measures taken on the premises.
- 7) Any visitor who causes any damage to the Museum by his/her fault is obliged to compensate it in accordance with generally valid regulations.

VI. Fire Protection and Visitor Safety

- 1) Smoking and handling of an open fire are strictly prohibited inside the bunker. When smoking in front of the object, it is forbidden to discard butts outside the reserved area.
- 2) Visitors are obliged to pay increased attention to their personal safety, especially when moving on stairs, corridors and under ventilation shafts in the bunker, or open areas near the building.
- 3) In the event of failure of artificial lighting, the visitors shall stand still and follow the instructions of the guide.
- 4) In the case of repeated non-compliance with the security instructions and violation of the Visiting Regulations, the visitor shall be banished from the premises without compensation of the admission fee.
- 5) Klub vojenské historie Bohumín (Military History Club) assumes no responsibility for accidents and damages resulting from the violation of the Visiting Regulations.

VII. Final Provisions

- 1) Visitors may submit their wishes, complaints and comments in writing to the Guestbook available in the building, or they may approach with them any statutory representative of the Club.
- 2) These Regulations enter into force on the day of their issue.
